Re: Application for approval of the preparation PMV-01 under Regulation 1107/2009 *Pepino mosaic virus*, strain CH2, isolate 1906 is a new active substance for which De Ceuster N.V., Belgium submitted an Annex II dossier to the Belgian authorities acting as Rapporteur Member State, in 2012.

The evaluation of the Annex II dossier is in its final phase. The Draft Assessment Report and Conclusions on the Pesticide Peer Review of the active substance *Pepino mosaic virus*, strain CH2, isolate 1906 have been made public (see EFSA Journal 2015;13(1):3977 of January 9, 2015). The inclusion of *Pepino mosaic virus*, strain CH2, isolate 1906 on the Annex I list is expected within a few months.

The end use product PMV -01 for which we are now applying for approval is containing the new biological active substance *Pepino mosaic virus*, CH2 strain, isolate 1906. It was also the representative formulation in the Annex II dossier. PMV -01 is identical to the technical concentrate Tomato watery leaf extract containing *Pepino mosaic virus*, strain CH2, isolate 1906. Since large-scale purification of the virus particles from tomato leaves is not feasible, all research and data included in the Annex II dossier for the active substance were conducted on the technical concentrate Tomato watery leaf extract containing *Pepino mosaic virus*, strain CH2, isolate 1906. As a consequence most of the data included in the Annex III dossier for PMV -01 are the same as those included in the Annex II dossier for the active substance *Pepino mosaic virus*, strain CH2, isolate 1906.

PMV®-01 is used as a biocontrol agent in tomato crops under protection. Therefore there is only one zRMS needed for the three European Zones.

The Annex III dossier will be submitted to the Belgian authorities acting as zonal Rapporteur Member State for the three European zones. A copy will be sent to the competent authorities in the following Member States acting as concerned Member State.
