A little later than I hoped, please find the NL-comments on the draft summary report of the Workshop GD Bees of December 2013.

Also, I would like to take the oppportunity to send you our NL Actionprogramme Beehealth, that is drafted by stakeholders and my ministry and has been discussed in Parliament last December (English translation). I also include the original Dutch version of the Actieprogramma Bijengezondheid and the reaction of my minister to the NL Parliament (in Dutch).

Meanwhile several of the actions have started as (work in) projects. Some funded partly by government and industry or by government and growers association or government and NGO's. Others solely by citizeninitiatives or the bee-keepers associations. This Actionprogramme Beehealth is followed-up by a so-called Bee-Council ('BijenBeraad') that consists of all stakeholders (from Greenpeace and Nature&Environment, beekeepers, growers associations, bee-citizen-initiatives to the NL seed-association and ppp-industry. Also Water-Board, regional governments and the government take part. If you have any questions, please do not hesitate to contact me in the matter.

Dear all,

As a follow up of the workshop on the EFSA Guidance document on the risk assessment of PPP on bees, we would like to establish a Working Group “Roadmap/timeline for the Implementation of the EFSA Guidance Document on Bees”.

We are pleased to inform you that the first meeting of this Working Group will take place in Brussels on **31 March 2014**.

The objective of this first meeting is to agree on the "roadmap". Subsequent meetings are foreseen for a smaller Steering group for the implementation. Members of this group would need to actively contribute to the implementation by e.g. follow the scientific developments

in the area, comment on proposed test protocols and participate in meetings of other groups/organisations that actively work with development of test methods for honeybees, bumble bees and solitary bees, with the objective to as soon as possible make it possible to conduct a complete risk assessment for bees in line with the data requirements.

The official invitations, the agenda and the relevant documents will follow soon.

Meanwhile, we would be grateful if you can nominate the experts who will attend the working group.

Please be aware that for organisational reasons, we have to restrict participation to one expert by Member State.

We expect to receive the names of the appointed experts by the 20 March 2014 at the latest.
