- 2. A health survey among residents not in the same league as above, but still interesting. One relation is to be noted: living in the vicinity of maize fields and lung-problems. Most probably not linked to pesticides but to the intensive animal husbandry, which is correlated with the cultivation of maize as feed for the animals.
