Thank you for your reply.
In Denmark we do not have a ban on the sale (or use) to non-professional use of PPPs containing Glyphosate.

We do however have certain restrictions on the sale and use of all PPPs (regardless of active substance) to non-professionals as a consequence of the sustainable use directive.

Dear 5.1.2.e WOO,

The Netherlands haven't put restrictions on the sale or use of Glyphosate products for non-professional use. Our policy was the prohibition of the use on pavements for both professional and non professional use. Last week our state secretary informed the parliament the prohibition of the use of plant protection products on pavements will be restricted to the professional use, as a result of an advice of our Council of State. The prohibition of the professional use on pavements will enter into force in March this year. In the meantime we will look for possibilities to expand the prohibition to non professional use on pavements. Later, in November 2017, the prohibition of the use of plant protection products will be expanded to all professional use except from agricultural use. In this policy there is no differentiation in specific plant protection products such as Glyphosate.

I hope this information will be useful for you. I am also very interested in developments in your country, such as restrictions on sale or use.
