Thank you for this proposal, in general we agree with it. Concerning the Glyphosate-webtext, we have only one, small remark: Answering "Why a group of RMS and not a single RMS?" you write "Following *extensive* discussions..." We prefer to delete 'extensive' to make this sentence and message more neutral.

As you state, this is an appropriate update from https://ec.europa.eu/food/plant/pesticides/glyphosate_en. We suggest that as a sub-site

from this page, there comes a link to an AGG-page and think it would be good to publish there (and/or at a news site from the EC) the short press announcement [redacted] and I wrote last monday. The advantage will be that other (AGG-) Member States, NGO's and press can copy this short *news item* one to one to their own publications and websites without further (mis)interpretation.

Finally we have the question when you plan to publish all this information, before or after SCoPAFF? I'm asking this because our Minister informed the parliament about the SCoPAFF topics, but didn't mention yet the proposed AGG. So for us it would be good to publish directly after SCoPAFF – for example Friday 22nd - so our Minister can inform the parliament at the same time.
