Dear 5.1.2.e Woo

thank you for your comment. The information that I communicated to the AGG is the detailed picture, and one of my main principles is to always be correct and transparent in what I communicate to authorities.

The topic with communication is that sometimes the colleagues choose too "simple" terms that may lead to misunderstanding. Ideally we should say that the GRG put the summary dossier on our website, readily available for download, and that we make the underlying study reports available on request (either by using the hyperlinks in the reference lists or by contacting the GRG via the "get in touch" form).

As communicated earlier to the AGG, all the new study reports (as listed in our Application document) are already available in sanitized form (and have been shared with the AGG).

However, we did not work on pro-actively sanitizing the study reports from the 2012 submission but decided to only start the sanitization of a specific study report once it is requested by an online order (which in fact did not happen for the 2012 studies so far, but there is an interest in obtaining the new study reports).

As discussed, recently we changed our policy regarding pro-actively sanitizing the old study reports, as communicated to the AGG, and we are committed to sanitize the active ingredient related safety study reports regarding tox, residues, e-fate and ecotox now pro-actively. The work in this area is progressing, and we will provide batches of marked study reports to the AGG once they become available (batch of tox studies to be delivered soon).

Does this clarify the situation? We can always have a quick call in case of any doubts.

Thank you for your feed-back, since it is important for us to learn how our communication resonates.

**Subject:** Glyphosate dossier available to the public

Dear colleagues from Permanent Representations,

The [Glyphosate Renewal Group](#) (GRG), of which Bayer is a member, took an unprecedented **step to bring transparency of risk assessment to the next level**: the GRG made publicly available online the dossier with scientific evidence on glyphosate safety that will be now evaluated by the competent regulatory authorities that form part of the Assessment Group on Glyphosate (AGG, composed of the regulatory bodies of France, Sweden, Hungary and the Netherlands).

While the submission of the dossier and its evaluation are fundamental parts of the process to seek the renewal of the glyphosate EU approval by end-2022, **its publication is an unprecedented milestone of the GRG voluntary Transparency Commitment**. This flagship initiatives makes easily and publicly available all the official documents from the process to renew the glyphosate EU authorisation: application, meeting minutes etc.

**The Glyphosate Renewal Group put the scientific dossier on its website after the AGG concluded that the dossier is complete and admissible for the purposes of its science-based evaluation and glyphosate risk assessment.**
