Onderwerp: Glyphosate - extension of approval period

Dear colleagues,

A Commission Implementing Regulation amending Implementing Regulation (EU) No 540/2011 as regards the extension of the approval period of the active substance glyphosate has been adopted this morning, 29 June. It will be published in the Official Journal of the European Union tomorrow, 30 June.

The articles are identical to the version on which a vote was taken at the Appeal Committee on 24 June 2016, so the new expiry date is "6 months from the date of receipt of the opinion of the Committee for Risk Assessment of the European Chemicals Agency by the Commission or 31 December 2017, whichever is the earlier".
