Herewith we would like to inform you regarding the decision of the Board for formulations containing glyphosate and the co-formulant POE-tallowamine.

The provisional decision of the Board is a withdrawal of the formulation(s) per August 22, 2016, with the following grace periods:

- grace period for the sale and distribution (in Dutch: AFLEVERTERMIJN): 3 months;
- grace period for the disposal, storage and use of existing stocks (in Dutch: OPGEBRUIKTERMIJN): 3 months.

This decision is provisional. The Board has received different views / opinions / information in the recent days. These views / opinions / information will be considered by the Board. The Board will come in the short term (expectation: next week) with a final decision.

We hope to have informed you sufficiently for the moment.

We contacted you about the Commission Implementing Regulation (EU) 2016/1313 of 1 August 2016 amending Implementation Regulation (EU) No 540/2011 as regards the conditions of approval the active substance glyphosate.

In the Regulation is stated that "Member States shall ensure that plant protection products containing glyphosate do not contain the co-formulant POE-tallowamine (CAS No. 61791-26-2)".

According to our data-base the following products contains the above mentioned co-formulant:
